Pursuant to Chapter 170 of the Code of the Town of Elmira, the owner of each building containing one or more rental dwelling units shall complete this form and register the building with the Town Code Enforcement Department.

Within sixty (60) days of the transfer of ownership, or a change in the information provided below, the owner shall complete and submit a new registration form for each building affected by the change.

Post Office Boxes shall not be accepted as address(s). The building intended to be registered shall not be utilized as the owner's or agent's address unless it is the principal place of business or residence of the owner or agent. If space provided is insufficient, please submit the additional information on the "Additional Information Sheet". This form is available upon request.

<u>Please be advised</u>, in addition to any other remedies available under law, any owner of a property which contains a building with one or more rental dwellings units who fails to comply with the requirements of section 170-5 must apply for and obtain a Probationary Certification pursuant to Chapter 171-5. If the owner fails to comply with the aforesaid requirements, the owner or the person in charge can no longer collect rent for such dwelling unit(s) and the renter shall have an absolute defense in any action to recover rent or to recover possession of the dwelling unit(s) for nonpayment of such rent. The owner may also be prohibited from renting the dwelling units in the respective building and be subject to the penalties set forth in section 170-3(a). Finally, the owner may be subject to a shutdown notice.
