

At the workshop of the Town Board of the Town of Elmira, Chemung County, New York held Wednesday, March 15, 2023 at 7:00pm at 1255 West Water Street, Elmira, NY, there were present:

Supervisor Sullivan called the workshop to order at 7:00pm and lead attendees in the Pledge of Allegiance

### **Discussion**

Supervisor Sullivan introduced Phil and Gregory who attended the meeting on behalf of GETA. The board discussed the options for repairs on the tennis court. Supervisor Sullivan recommended the board decide how to proceed within the next 30 days.

Supervisor Sullivan informed the board the town received a new agreement for highway services. This agreement will be from 2/5/2023- 2/4/2024 at a cost of \$62,739.00. The Town has the option of renewing for an additional year. It is recommended that this agreement be approved at the March 20, 2023 Town Board meeting

Supervisor Sullivan Spoke to the board regarding an inter municipal agreement to extend the bike corridor up Davis/Oakwood to the E. Heights boundary. It is recommended that this agreement be approved at the March 20, 2023 Town Board meeting

The Town Board discussed the Stormwater Coalition agreement. Councilmember Allison described to the board how the amounts are figured per municipality. Councilmember Bush spoke regarding the percentages that each municipality increased/decreased. The board decided to look further into this.

Supervisor Sullivan stated that he spoke to the Highway superintendent and in mid-April the basketball courts will be reducing footprint from two courts to one court with greenery around it.

The board discussed the pickleball courts and the request from the pickleball association to use the courts for their league nights on Wednesday nights throughout the Summer/Fall months.

Supervisor Sullivan informed the board we were approached regarding the dog wastes being left in yards and on sidewalks. Due to this being a sanitary issue the board has agreed to purchase dog waste stations. These stations will be placed on the Town Hall property, Community Bank property and at the point in hopes that this will help with the wastes not being left along the roads.

Councilmember Lucarelli spoke in regards to the higher volume of trash cans being left on streets for longer periods of time. This is believed to be caused by the multiple garbage companies being used by residents and pick up dates and times have changed.

Supervisor Sullivan stated that Code Enforcement Officer Crandell has been appointed to the Chemung County Stormwater Management Team Board of Directors.

Motion was made by Councilmember Bush at 7:54 pm and seconded by Councilmember Lucarelli to enter into an executive session to discuss litigations. All in favor, motion carried

Motion was made by Councilmember Lucarelli at 8:25 pm and seconded by Councilmember Allison to exit executive session and reconvene the workshop. All in favor, motion carried

Motion was made by Councilmember Bush at 8:26 pm and seconded by Councilmember Allison to adjourn the workshop. All in favor, Motion Carried
