Supervisor Sullivan presented a Power Point to explain further about the Rescue Plan aid to local Governments. He also recapped the meeting with Empire Access letting residents know that they plan on building in West Elmira on Water and Church Street and expanding out from there. They do not have a time-frame, as permitting with DOT is taking longer than expected. Supervisor Sullivan also touched base on some budgeting updates, explaining the difference between timing variances versus missed budget projections. Supervisor Sullivan acknowledged Chief Richards as the town received a phone call on his compassionate, professional manor during a recent call. He also thanked Town Clerk Tammy Stein on her work with Verizon saving the town about \$2000.00 per year on their phone plans.

Discussion:

Roads Committee- Councilmember Bush spoke saying him and Councilmember Lucarelli meet with Matt Mustico and Matt Davis, he stated they reviewed the 2021 road program and Town Clerk Stein will be sending letters out to inform residents of work being done on their road. The Highway department was asked to keep track of all shared service hours.

Highway agreement- Supervisor Sullivan explained that we will be approving a resolution for Shared Highway Superintendent. He is working with the Village of Horseheads on an updated contract with them as the Highway Superintendent/Mechanic services.

Attorney Scott Moore explained the process of the conveyance of property on Morningside Dr as a resident would like to purchase 3 of the Towns properties.

Department Reports:

Police Chief, Robert Richards read the activity report regarding the calls, stops, etc. done in his department for the month. He also informed the board that he and Officer Saunders participated in the Easter parade for the Town. He explained the difference between Penal law and Traffic law per Councilmember Lucarelli's request.

Code Enforcement Officer, Eric Crandall read his report regarding the permits in March. He also talked about the fire at 10 Summit Dr. The family is still not living there and is waiting on information from their insurance company. There was another fire at 84 Curren Dr caused by an electrical issue. He said the Fire Department did an outstanding job by responding so quickly and they were able to save the house with no structural damage. Eric also touched base on the 82 Greenridge property stating he's tried contacting them and hasn't got a reply.

Eric also recognized the passing of Rick Emanuel stating he was a great community member; he was very committed to this community. Rick also filled a seat on the Zoning board of Appeals. Highway Superintendent, Matt Mustico reported they have started the 2021 road work on Arcadia Dr by working on the drainage. The highway department has been cleaning ditches, sweeping the roads and working on cold patching. They will have 2 kids from the Boces program helping them soon. The cameras at the Compost facility and Town garage are up and running and have great quality and work very well. They will be getting free gravel from the York Ave. project that will be used at a later date.

Supervisor Sullivan stated that the pipes are back together and he'd like to have the bathrooms open soon in the park. He also informed the board that Corey, caretaker cleaned up the benches after a bunch of graffiti was put on them. He and Chief Richards discussed the progress with the

cameras that will be put in the park.

Mia Devlin, Lovell Ave. asked the town board if they could do something about the bee issue at the park. Supervisor Sullivan stated he will discuss with our caretaker.
