Department Reports

Code Enforcement Officer- Eric Crandall stated that May was a little slower month. He took in 19 permits. He had a few complaints that he addressed. Eric informed the board that the Electric Vehicle charger is being used 4-5 times a month now. The East Hill garage lights are installed and we should be getting reimbursed in near future. Councilmember Lucarelli inquired about the progress of a property on Greenridge, Eric stated that the homeowner is making progress and has to wait for some material to complete the outside work. Eric informed the board his permit was valid until October.

Highway Superintendent- Matt Mustico let the board know that the scheduled paving is complete. They've also done oil and stone. They have taken care of some trees that have fallen

the past few weeks. Matt also informed the board they are cleaning out the Whirt's creek again and will be putting concrete in. A few of the guys worked on the paving truck to get that up and running more efficiently, as the department will start patching soon. Councilmember Bush told Matt that he is very pleased with the work that was done on the roads, they did a great job. He plans on starting work on Demerest between Church and Water mid-July.

Recreation Coordinator- Patty Carozza said that the TCC rentals are down but is working with some ideas to get more people into the building. Patty spoke about some events that her and resident April Peris had planned and are looking into planning. She stated that the Bike Bingo was a success and that all who participated seemed to have a great time. Patty spoke about the summer camps as well.
