Resolution for Surplus Presentation- HeatSmart Thompkins/ Chemung

Department Reports

Highway Superintendent- Matt Mustico stated that some drainage pipe is becoming hard to find and he has found a company he can purchase in bulk and would like to do this so he can have some on hand. He discussed the wind damage to trees and the rain damage. He is hoping to be able to work on Demerest but is waiting for NYSEG to finish. The highway department is working on patching as well.

Police Chief- Robert Richards discussed the number of calls, stops and arrests that were made in June. He informed the board that the radar trailer delivery date has changed and it will be shipped by July 23rd. Chief Richards informed the board that he, Officer Macbeth and Officer Marrone have interviewed and done checks on all the new hires and feel they will be an asset to their department. They will be reinstating 2 part time officers whom are coming from other agencies and 1 full time officer whom will be starting academy August 9th. Chief Richards is waiting for the Civil Service test results which should be certified on August 3rd to be posted. They will prospect for a 5th Full Time Officer at that time.

Code Enforcement Officer- Eric Crandall stated that June was a busier month. He took in 29 permits. His office has been very busy between permits, inspections and paperwork. He has sent some tall grass notices to residents. He discussed the sidewalk program per Councilmember Bush's request. Eric discussed there not being a code with Councilmember Lucarelli regarding cars parked in yards.

Public Comments

Sue Hamlin, West Church St asked the Town Board for an update on Empire Access coming to the town. Supervisor Sullivan informed her that the State received the application and Empire is waiting for the approval.

Joe Colletta, Hendy Ave. discussed his concern regarding the fireworks in the town with the Board. Chief Richards stated they did not get any complaints on the 3rd and 4th regarding

fireworks. He inquired about whether permits are needed at which Code Office Crandall informed him of the process.
