Road Committee

Councilmember Bush stated that he, Councilmember Lucarelli, Matt Mustico, Matt Davis and Supervisor Sullivan met on September 7, 2021. In the meeting they discussed that Demerest will be paved this fall, and that will complete the planned projects for 2021. The new Dodge Ram truck is getting fitted with a plow and dump body and should be available before the snow season. They have been working on a list of roads to be repaired in the 2022 road program. The road committee will meet again October 5th.

Councilmember Lucarelli added that the Highway department is keeping an inventory of hours and usage of their equipment.

Budget Update

Supervisor Sullivan stated that at this time they are not anticipating a tax increase. There should be a decrease in the lighting district once the lighting project is complete. The board is still in negotiation with the Fire Districts regarding their budgets.

Department Reports

Code Enforcement Officer- Eric Crandall stated that August was a fairly busy month with a little over \$1200.00 collected. He sent out a few high grass violations. Eric and Councilmember Lucarelli discussed a property on Greenridge. Eric was pleased to announce that he spoke with Edger Enterprise and they started the pickleball work and are anticipating getting the majority of the work done this year.

Chief Richards read his report regarding the calls, arrest and other reporting incidents for August. He informed the board that Officer Matt Saunders assisted in an incident that occurred in the city and because of his selfless acts he was given a letter of gratitude from Chief Alvernaz of the City of Elmira Police Department.
