#### **Department Reports**

Supervisor Sullivan stated that all department heads were excused from this meeting but all have submitted a report for the board to review.

#### **Discussions**

Supervisor Sullivan spoke to those in attendance stating that the backstory is that more than ten years ago Paul DiPietro attended Board meetings at least a couple of times per year, to remind the Town about the importance of planting trees, about how a healthy tree canopy adds to property values and is better for the environment.

Paul was steadfast in his belief that the work needed to be done, and his knowledge on the topic was impressive.

He led the effort to partner with Cornell University many years ago to complete an inventory of our existing stock. The resulting study was a great starting point to determine what needed to be done.

The tornado back in 2015 took out a great many trees and Paul said we have to get to work. We started small, planting 5-10 trees per year and last spring we decided, with the help of the ARPA money, to plant 100 trees by the end of 2023.

Paul led the committee, was our best cheerleader, and his efforts resulted in 50 street trees being planted this year. In addition, another 20+ trees were planted in the park.

The Highway Department, town hall staff and town residents have been partners in this effort, but because of Paul DiPietro's dedication over the years, Supervisor Sullivan presented to him, on behalf of the board, the 2022 Supervisor's Award, as a small token of our gratitude and esteem.

Paul was very pleased with receiving this award and spoke about the process and those who helped make this possible.

Supervisor Sullivan stated that the next two resolutions were referred to the Chemung County

Planning board for review. They were returned to the Town Board with no objection to changing the wording to better align with town code. They suggested the Town develop a special use permit to allow residents to have animals that are already covered in the code.
