Supervisor Sullivan called the Town Board workshop to order at 7pm and asked others to stand for the Pledge of Allegiance

Discussion

Supervisor Sullivan discussed the Code for Peddling and Soliciting in the Town of Elmira with the Town Board. Attorney Moore will look into this further to discuss at our June 21 meeting.

Supervisor Sullivan discussed the West Elmira Recreation Contract with the Town Board. He asked to add this as a resolution to approve the contract.

Supervisor Sullivan stated that the Town updated their survey of the Town Campus. The Town Board discussed the fencing at the entrance and options to make that area a nicer view when entering.

Town Clerk Stein updated the Town Board on the progress of the new website stating a launch time of this fall.

Supervisor Sullivan updated the Town Board on the park, stating that the cameras are all in place for the Police to view. He stated the pool house project is complete and looks great. The Town Board discussed resuming the season passes if the capacity limit is lifted. Councilmember Lucarelli inquired about the dog park. Supervisor Sullivan informed him it was researched and there are restrictions on sizes and there is not enough open space available in order to accommodate a dog park on the campus.

The Town Board discussed the parking on Chapman Place. Supervisor Sullivan stated he has patrolled their 12 different times and stated the vehicles seem to have their routine parking places. The Board has suggested set an odd/even parking ordinance from November 1- April 1 allowing Superintendent Mustico or his designee to enforce traffic control giving them authority to ticket those not following the ordinance. Attorney Moore is looking into this further.

Supervisor Sullivan informed the board that a speed trailer was ordered and should be delivered in later June or July. He worked with Sgt. MacBeth to draft an agreement regarding new hires

and a financial payback if they do not stay employed with the Traffic District for a designated amount of time.

The Town Board discussed updating the signs at the Highway garage regarding the compost.
